UNIFIED DEVELOPMENT CODE ORDINANCES AND AMENDMENTS

ORDINANCE NO. 13-0124A..... ADOPTED UNIFIED DEVELOPMENT CODE (UDC)

ORDINANCE NO. 13-1212B..... AMENDED ARTICLE 8, SPECIAL USES AND GENERAL REGULATIONS, BY AMENDING PROVISIONS IN SECTION 8.2, ACCESSORY USES AND STRUCTURES, AND SECTION 8.3, ACCESSORY DWELLING UNITS, AND UPDATING FORMATTING.

ORDINANCE NO. 14-0626C..... AMENDED ARTICLE 5, ZONING DISTRICTS, AND ARTICLE 14, DEFINITIONS, BY AMENDING TABLE 5.7, PERMITTED USE TABLE; ADDING SECTION 5.12, TEMPORARY USE PERMIT (TUP); ADDING, DELETING, AND REVISING DEFINITIONS IN ARTICLE 14; AND UPDATING FORMATTING. THE AMENDMENTS PRIMARILY RELATED TO GASOLINE STATION/FUEL PUMPS, TRUCK STOP, AND ASPHALT/CONCRETE BATCHING (TEMPORARY) USES AS WELL AS VARIOUS OTHER TEMPORARY USES.
